NEW BALLET FEST – June 20-21

Connecticut Ballet's 2008-2009 season comes to a close with **NEW BALLET FEST**, featuring new works commissioned from three exciting choreographers: **Betsy Cooper**, free-lance choreographer and Associate Professor of Dance at the University of Washington, **Katie Stevinson-Nollet**, Artistic Director/ Founder of Full Force Dance Theatre and faculty member at the University of Hartford, and **Rodney Rivera**, principal dancer and resident choreographer of Andanza Contemporary Dance Company of Puerto Rico.

All three works will be premiered on **Saturday, June 20th at 8:00pm** when the company makes its return to Riverfront Recapture in Hartford with generous support provided by Ensworth Charitable Trust, Greater Hartford Arts Council, and Edward C. and Ann T. Roberts Foundation. Admission is free.

Connecticut Ballet launches new in-school assembly program: **PIONEERS OF AMERICAN DANCE**

On a bitter cold February morning, Connecticut Ballet performed our newest in-school offering, *Pioneers of American Dance*, for five hundred eager Riverside Elementary School students. Ten dancers brought to life the choreographic legacies of the likes of Isadora Duncan, Alvin Ailey, and Gene Kelly. Narrated by Brett Raphael, the students and educators sat in rapt attention throughout the 50-minute program (except when they were encouraged to try out signature movements or gestures).



On March 12, the program was showcased for art and music supervisors and pto reps from the around the state. Laurie McTeague, a *Friends of Connecticut Ballet* member, brought a representative from her son's Montessori School. In a follow-up email, she commented: "*(The program)* masterfully traces the arc of modern dance development and innovations in this country (and by extension, the world). This is an historic, artistic context to which very few people are ever exposed. It's a powerful and joyful story

Connecticut Ballet Awards First Khalda Logan Dance Scholarships in Danbury



Khalda Logan was a gifted professional dancer in Nicholas Leichter Dance Company, professor in dance at Western Connecticut State University, and a founding member of Connecticut Ballet's Danbury Dance Initiative in 2005. She passed away from cancer in 2007. In memory of her dedication to dance education, Connecticut Ballet and the Khalda Logan Memorial

Foundation jointly created the **Khalda Logan Dance Scholarship** to provide accelerated training opportunities for middle and high school students.

The 2009 awards were presented at the Third Annual Danbury Dance Initiative benefit performance, Sunday, March 8th, at Broadview Middle School in Danbury. Broadview Middle School students **Victoria Lemme**, **Roslyn Perkins**, and **Kathryn Sullivan** shared second prize (\$500 each). First prize was awarded to Danbury High School junior **Mariel Vicente** (\$1000), a longstanding student at Dody Flynn's Dance Dimensions studio in Danbury. Khalda's husband, Michael Eaton, was on hand to meet the winners and represent Khalda's legacy.

An exciting documentary short about the 2009 audition/awards process produced by **J.C. Barone**, Digital Film/ Video Production & Aesthetics professor at WESTCONN and filmed by Ronald Rosario, film intern, will be posted on Connecticut Ballet's Facebook page and on YouTube shortly. Stay tuned and congratulations to all four winners!

Footnote: In the fall of 2005, Connecticut Ballet launched the **Danbury Dance Initiative**. The program brings annual assembly programs to all the elementary and middle schools, public performances by the ballet company at the Ives Center, Danbury High School and CityCenter Summer Series on the Green, dance showcases featuring local schools and choreographers, and special outreach classes to under-served youth in partnership with agencies such as Escape to the Arts and Department of Children and Families. A task force of prominent educators, social service directors, dance school owners, arts administrators, and funders guides the Initiative and meets quarterly.

• **99 at 99: Dancers on Display – Thursday & Friday, June 11 & 12 from 12-1pm** – Connecticut Ballet will present a site-specific original dance work, *99 at 99: Dancers on Display*, in the unique art deco lobby space of 99 Pratt Street, the downtown property owned by Alkon Trumbull Street LLC. The building houses administrative offices for several prominent arts organizations, including Hartford Stage, Hartford Symphony Orchestra, and Connecticut Ballet. Choreographed expressly for this occasion by Artistic Director Brett Raphael and

using the eight glassed-in display areas in the lobby space, the event will celebrate Pratt Street as a 'downtown arts destination' and help promote the ballet's June 20th Riverfront Recapture performance.

"My idea was to create a piece to celebrate our arrival in downtown, to bring dance into the gorgeous lobby space of our building," stated Raphael. "My challenge will be to choreograph 99 separate movements for each of eight dancers on display in a very public, but very confined space. It's our version of the old-fashioned penny arcade for the enjoyment of the downtown lunch crowd."
